Household Hazardous Waste

Improper disposal of household hazardous waste is a threat to our environment. Thrown in the trash, down the drain or on the ground, leftover chemicals can contaminate our air, water and land. The best way to avoid this contamination is to educate yourself. Only buy what you need or consider donating to those in need.



We are proud to offer eight, one-day household hazardous waste collections each year for Bergen County residents. This popular and widely utilized

program is free. We will accept a wide range of chemicals used in and around your home. Please keep all items in their original, labeled containers and store them out of reach of children and pets. No containers, including gasoline and motor oil containers, will be returned, so please plan accordingly.

The BCUA conducted eight, one-day household hazardous waste (HHW) management events in 2023. These events were held at three different locations throughout Bergen County. In all, 12,653 Bergen County households took advantage of these events to dispose of 1,024,550 pounds of unwanted hazardous waste materials. These events continue to be the largest attended, one-day events in the state of New Jersey.

Brush up on your knowledge of paint

Not all paint is considered hazardous. **Latex paint** is water based and is not considered a hazardous waste. It may be disposed of safely in the garbage IF you take the following necessary precautions: Dry it out! Remove the lid. Either use a paint hardener or stir in an absorbent material such as cat litter into the paint can. Allow paint to solidify and then empty into newspaper and dispose of in the trash.

Oil Based paint is a flammable material and must be disposed of properly. Donate it, use it up or take to a BCUA HHW collection.

(non-hazardous and use-once)

(hazardous and multi-use)

Lithium Ion, Nickel Cadmium (Ni-Cad),

Small Sealed Lead Acid

Dispose of properly. Recycle with

Other Batteries (hazardous and use-once)

Name on battery:

Lithium, button cell, not rechargeable.

Mobile Paper Shredding

Residents may deliver their confidential paper documents to various locations and observe as their documents are shredded on site. Acceptable documents are limited to confidential and sensitive materials only. Non-confidential materials, such as junk mail, books, magazines, and newspapers, should be recycled through your local municipal recycling program and will not be accepted. There is no need to remove paper clips, staples, or paperboard binder covers. To accommodate all of those wishing to participate, there is a limit of four (4) bags or boxes of documents weighing no more than 10 pounds each.



The BCUA offers each municipality the opportunity to host a collection event at a municipal site of its choice. [Check here for your local collection.](#) No businesses are permitted to participate. In 2023, 65 municipalities opted to participate in this program. In addition, the BCUA sponsors four one-day, county-wide collection events for residents at two locations in Bergen County. Through these programs, the BCUA collected a total of 481,739 pounds of confidential paper for destruction and recycling. [Click here for 2024 BCUA collection events.](#)

Tire Recycling

Since 1995, the BCUA has sponsored a Municipal Tire Recycling Program. With over 240 million tires being discarded every year, tires take up large amounts of landfill space unnecessarily and present an adverse environmental impact on our solid waste stream.

During 2023, the BCUA collected 1,153 tires from Bergen County residents for recycling.

FOR RESIDENTS: The BCUA hosts four (4) one-day drop-off events for tire recycling. There is a limit of four tires per participant. Tires with or without rims will be accepted. These events are for Bergen County residents only (no businesses). Proof of residency required.

Computers and Electronics

The New Jersey Electronics Recycling Act mandates that as of January 1, 2011 all televisions, portable desktop or personal computers and computer monitors can no longer be disposed of in any landfills; and that they must be recycled.

During 2023, the BCUA collected 123,680 pounds of computer and electronic equipment for recycling from both residents and businesses.

FOR RESIDENTS: Most Bergen County municipalities offer an electronics recycling program so we ask that you contact [your local department of Public Works](#) first to see if an electronics recycling program exists in your town. The BCUA operates the Computer and Electronics Recycling Depot

for all Bergen County residents at the BCUA, Foot of Empire Blvd., Moonachie. **This depot is open Monday through Friday, from 8 a.m. to 2 p.m. This depot is not staffed, so please plan accordingly.**

FOR BUSINESSES: The Computer and Electronics Recycling Depot accepts equipment from businesses. Contact the BCUA Environmental Programs Hotline at 201-807-5825 for complete details.

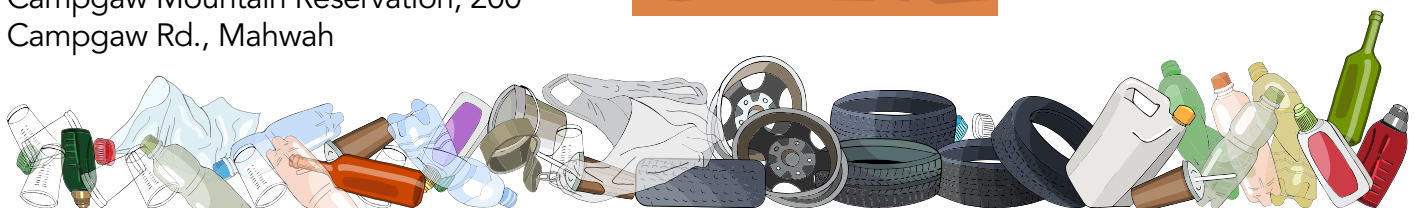

Recycle Right!

Only recycle what is acceptable in your municipality. Be careful to follow the recycling guidelines as advertised by your local area. Guidelines provide specific details about the materials that are and are not acceptable. If you put it in the recycling bin and it's not in the guidelines it becomes garbage. Another useful tip – Don't bag recyclables.

Unacceptable materials increase the cost of operation and lower the value of recyclables. Visit your local municipal website for guidance.

Yardwaste Management – It is easy being green!

Backyard Composting helps the environment and is nature's way of recycling! Composting allows residents the opportunity to turn their yard waste and kitchen scraps into something useful - rich garden soil. This is a form of recycling that can be done from beginning to end in your own backyards. Backyard compost bins turn vegetative kitchen scraps, coffee grinds, tea bags, grass clippings, brown leaves, and dead garden plants into nice crumbly compost. This compost can be used in your vegetable and/or flower gardens. Click here for a brochure and to learn how to build your own compost bin.

Grasscycling: Cut it and leave it. Lawn experts have found that short grass clippings left on the lawn act as a natural fertilizer, producing a healthier lawn that greens earlier in the spring and stays green later into the fall. Grass clippings shelter the tender grass roots from the sun and conserve moisture. Grass clippings help to create a thicker, healthier lawn that is more resistant to weeds and certain lawn diseases. Grasscycling does not cause thatch. Short grass clippings decompose within a few days. Save money and Cut it and leave it! [Click here for a brochure.](#)

MOBILE PAPER SHREDDING



Give your paper a safe retirement – shred it!

Recycle your confidential documents such as, bills, receipts, tax returns, medical records, legal documents, etc. safely by shredding them. (Recycle magazines and non-confidential paper at curbside.)

In an effort to accommodate everyone, there is a limit of four (4) bags/boxes, weighing no more than 10 lbs. each.

Paper clips and staples are acceptable. Please remove binder clips.

Shredding performed immediately on-site.

***Shredding program will end prior to 2pm in the event the shredding trucks reach capacity.

ELECTRONICS & COMPUTERS



Recycle one “byte” at a time – bring us your electronics and computers!

Recycle laptops, monitors, cables, wires, speakers, computers, televisions, stereos, printers, and more!

TIRE RECYCLING



Give your tires one last spin – recycle them!

Four (4) tire limit, per delivery. Tires with or without rims accepted.

UNWANTED MEDICATION



Discard your unwanted and expired over-the-counter and prescription medications in a secured Project Medicine Drop box.

Bring medication in original containers or a sealed bag. **Sharps and liquids will not be accepted.**

You can also dispose of unused and expired medications anonymously, seven days a week, 365 days a year, at “prescription drug drop boxes” located within the headquarters of participating police departments. From the North (via Route 17)

Turn right off Route 17 South onto Ridgewood Avenue (West) to Paramus Road. Turn left onto Paramus Road and continue approximately two miles to college; proceed around jug handle to main entrance.

From the East

Take Route 4 West to Paramus Road (Paramus Road is $\frac{3}{4}$ miles past Route 17 intersection.) Turn right onto Paramus Road and proceed north approximately two miles to Bergen Community College entrance on right.

From the South (via Route 17)

Take Route 17 North to Century Road exit, second exit to the right, proceed around cloverleaf over Route 17 onto Century Road (West). Continue to Paramus Road and turn right onto Paramus Road to college entrance on right.

From the West

Take Route 4 East to Paramus Road (exit under overpass). Turn right onto Paramus Road and proceed north for approximately two miles to college entrance on right.

UNACCEPTABLE MATERIALS FOR WASTE COLLECTIONS

- Any business or commercial generated waste
- Empty containers or hardened paint cans are garbage
- Alkaline batteries (AA, AAA, C, D, 9V) dispose in normal trash
- Unlabeled waste or containers with unknown contents
- Regulated medical waste, sharps, radioactive materials, and explosives
- Containers larger than five (5) gallons
- Any compressed cylinders (e.g. oxygen or acetylene)
- Pressure-treated lumber or railroad ties
- Computers, electronics, and tires are NOT accepted at waste collections.
- Smoke Detectors
- Construction/demolition debris
