ORDINANCE NO. 1076-15

**AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 119,
ARTICLE III, “RECREATION PROGRAM FEES” OF
THE CODE OF THE BOROUGH OF OLD TAPPAN TO AMEND THE
FEES CHARGED THEREIN**

BE IT ORDAINED by the Mayor and Council of the Borough of Old Tappan,
County of Bergen, State of New Jersey, as follows:

Section 1. Chapter 119-9, Article II, entitled “Recreation Program Fees” is
repealed in its entirety and replaced by the following:

119-9. Registration Fees.

The following are the registration fees for the Borough’s recreation programs.
The fee range shown are for the 2013-2016 calendar years. The Recreation Commission
shall set the registration fees for each of the calendar years 2013 through 2016 in an
amount not to exceed the amount shown.

Section 2. Repealer.

All ordinances or parts of ordinances inconsistent or in conflict with this Ordinance are hereby repealed as to said inconsistencies and conflicts.

Section 3. Severability.

If any section, part of any section, or clause or phrase of this ordinance is for any reason held to be invalid or unconstitutional, such decision shall not affect the remaining provisions of this ordinance. The governing body of the Borough of Old Tappan declares that it would have passed the ordinance and each section thereof, irrespective of the fact that any one or more of the subsections, sentences, clauses or phrases may be declared unconstitutional or invalid.

Section 4. Effective Date.

This ordinance shall take immediate effect upon passage and publication according to law.
