ORDINANCE NO. 1106-17

A CAPITAL ORDINANCE AMENDING ORDINANCE 1088-15 APPROPRIATING AN ADDITIONAL SUM OF \$54,000 FOR THE INSTALLATION OF HANDICAP ACCESSIBLE BATHROOMS AT THE GOLF COURSE BY THE BOROUGH OF OLD TAPPAN AND TO APPROPRIATE AN ADDITIONAL \$48,400 FROM A COMMUNITY DEVELOPMENT BLOCK GRANT AND TO APPROPRIATE AN ADDITIONAL \$5,600 FROM GENERAL CAPITAL SURPLUS

<u>BE IT ORDAINED</u>, by the Governing Body of the Borough of Old Tappan in the County of Bergen, New Jersey (not less than two-thirds of all members thereof affirmatively concurring) as follows:

<u>SECTION 1.</u> Capital ordinance 1088-15 of the Borough of Old Tappan, New Jersey adopted by the governing body thereof on October 19, 2015, is hereby amended to the extent and with the effect that Section 1, Section 3(b) and Section 5 thereof shall read as follows (changed text is underscored):

<u>SECTION 1.</u> The improvement described in Section 2 of this Ordinance is hereby respectively authorized as a general improvement to be made by the Borough of Old Tappan, New Jersey, for the said improvements or purposes stated in Section 2, there are hereby appropriated the sum of money therein stated as the appropriation made for said improvement or purpose, said sum being inclusive of all appropriations herefore made thereof and amounting in the aggregate to \$104,000 which is now available from a \$92,300 Community Development Block Grant and \$11,700 from General Capital Surplus.

<u>SECTION 3.</u> (b) It is not necessary to finance said appropriation by the issuance of obligations by the Borough of Old Tappan pursuant to the Local Bond Law of the State of New Jersey, for the reason that monies sufficient to cover the appropriation thereof shall be available from a <u>\$92,300</u> Community Development Block Grant and <u>\$11,700</u> from General Capital Surplus

SECTION 5. The sum of \$104,000 is hereby appropriated for the aforementioned purpose.

<u>SECTION 2.</u> The Capital Budget of the Borough of Old Tappan is hereby amended or established to conform with the provisions of this Ordinance to the extent of any inconsistency herewith. The resolution in the form promulgated by the Local Finance Board showing all detail of the amended or temporary Capital Budget and capital program as approved by the Director of the Division of Local Government Services, is on file with the Clerk and is available for public inspection.

<u>SECTION 3.</u> It is hereby determined and stated that no supplemental debt statement is required to be made and signed in connection with said appropriation, since the gross debt of the municipality, as defined under the Local Bond Law, is not increased by this Ordinance and no obligations in the matter of notes or bonds are authorized by this Ordinance.

SECTION 4. This Ordinance shall take effect after public	cation thereof and final passage as required by law.
