HOLD HARMLESS AGREEMENT FOR FILMING ON BOROUGH PROPERTY

This HOLD HARMLESS AGREEMENT is entered into this ____ day of _____, 20__, by and between the Borough of Old Tappan, in the County of Bergen, state of New Jersey (hereinafter the "Borough"), and _____ (hereinafter "the production company"), for and in consideration of the privilege to film a certain scope of activity and scenes on Borough property at the date(s), time(s) and location(s) specified on the Borough's Filming Permit Application.

The production company hereby agrees to indemnify and hold harmless the Borough of Old Tappan, together with its officers, employees and agents, from any and all claims for losses or damages or injuries to persons, property, or to agenda of the production company that arise in connection with the activities of the production company carried on under this Agreement.

In the event of any such claims or lawsuits, the production company shall assume all costs of defense, including any costs and fees incurred by the City or its agents. The production company shall provide automobile liability insurance (where applicable) and comprehensive general liability insurance in the amount of \$1,000,000.00 to the Borough and shall name the Borough as an additional insured on all policies. All insurance policies must include endorsements showing that coverage is primary and non-contributory and includes a waiver of subrogation. The production company will provide the Borough with an insurance certificate evidencing the coverage.
