ENGINEER'S REPORT

Borough Engineer Thomas Skrable reported as follows:

Road Opening Request – 103 Sycamore Court – this street was recently paved. He will be meeting with PSE&G next week and wanted to discuss road opening procedure with the Mayor and Council. Currently the requests come before the Mayor and Council and he commented on improving the process with the utility companies. It was suggested by the Council to have the utility companies sign-off on completion or have an inspector present during the job. A follow up report will be provided next month.

COUNCILMAN CIOCE - ENVIRONMENTAL / LIBRARY

The Environmental Commission meets this evening. The library requested a preliminary meeting with the Council for discussion on the budget.

COUNCILMAN CARNAZZA - RECREATION / GOLF / HEALTH

The Golf Commission added a new fee for college students. The Golf Course is up 33,000. Recreation Commission – Basketball has 17 travel teams – 326 kids signed up. The Board of Health meets tomorrow.

COUNCILWOMAN HAVERILLA - POLICE / SAFETY / SENIORS

Councilwoman Haverilla is happy to hear about the Golf Commission establishing a college fee. The Local Assistance Board is very happy about their Volunteer of the Year Award received at the Reorganization meeting.

COUNCILMAN NALBANDIAN - FINANCE / EDUCATION / ADMINISTRATION

A budget meeting will be held at 5:00 p.m. tomorrow. Woodcliff Lake is looking to share services with Old Tappan. They would allow use of their tennis courts, pool and 6 week summer camp program for the same price as a resident in trade for the use of the Old Tappan Golf Course at resident prices. The Council agreed with the concept on a trail basis for one year.

NEW BUSINESS

Cross River Fiber Presentation

Robert Sokota, representative from Cross River Fiber, was present to discuss installation of fiber optic network cables. He proposed to install one inch diameter fiber optic cables on existing telephone poles in Old Tappan. This would take approximately 2 - 3 days and his company would pay for police traffic control. Mr. Sokota described the proposed route of the cable line. Borough Attorney Allen Bell asked to be provided with current agreements they have with the utility companies; Verizon, Orange & Rockland and PSE&G.

Open Space Advisory Committee

Mayor Kramer advised that there is a suggestion to eliminate this committee. Councilwoman Haverilla stated that a lot of work was put into gathering a list of open space areas and then the committee dissolved. Borough Attorney Allen Bell advised that they can meet occasionally on an ad hoc basis. It was suggested to seek new members and meet once a year.
