ENGINEER'S REPORT

Borough Engineer Thomas Skrable reported as follows:

71 Haring Drive Seepage Pit – house was re-built due to a fire. The ordinance was modified pertaining to installation of seepage pits which is based on net increase in impervious coverage. The homeowner feels he should not have to install one because he did not have one before. Councilman Nalbandian recommended obtaining the square footage of the home prior to making a decision on the seepage pit. Thomas Skrable will gather that information and report back at next meeting.

Co-Operative Paving – D & L Paving agreed to begin work the first week in October. Thomas Skrable asked that the Borough Attorney write a letter to D & L Paving solidifying the start date which is important for paving this time of the year.
