HISTORICAL PRESENTATION

Mayor Kramer introduced John Hogan, Bergen County Clerk. Before beginning his presentation, he explained that temporary satellite offices are being set up around the county for three days at a time in municipal buildings from 10:00 a.m. until 2:00 p.m.; the idea has been well received. Schools can be visited; presentations can be made on elections, information on what the County Clerk's office does, and record keeping.

Mr. Hogan's presentation focused on "Around the County" initiative which began on March 30, 2015. He explained how they have found and preserved historical documents from each town and have put together a collage of some of those documents that they are presenting to each town for display in their municipal buildings. The Mayor and Council thanked Mr. Hogan for his attendance and presentation.

COUNCILMAN CIOCE - ENVIRONMENTAL / LIBRARY

Councilman Cioce attended the Library Board meeting on September 13th. They plan on holding a wine tasting event. They are on track with their budget. The Environmental Commission meets tomorrow evening.

Board of Education – September 19th is a "Day of Gold" for the Northern Valley Regional High School District where staff and students will be asked to wear gold as part of childhood cancer awareness month. Councilman Nalbandian asked that the Borough's Sign Ordinance be reviewed as it pertains to both business and personal signage on properties.

COUNCILMAN GALLAGHER - PLANNING / ARTS & ENTERTAINMENT / FIRST AID

The Planning Board will review a commercial application. Councilman Gallagher read the First Aid Corps August report. Stair chair and heavy lift training was held. EMT's attended a class on head injuries. They are working with the police on electronic charting.

COUNCILMAN BINAGHI -FIRE / DPW

Fire Department members were in Wildwood for their convention. They will have a medevac (helicopter) drill with Hackensack University Medical Center on October 2nd or October 9th. The DPW is getting ready for leaf season; the new employees are working out well. The building behind the DPW has been removed; bids were obtained for a new building to be installed.

MAYOR'S COMMENTS

Referred to and commented on correspondence Number 9. The Bergen County Utilities Authority awarded 3 grants to the schools. Mayor Kramer has received requests for memorial recognition for those who served the community. He has set up a committee of Councilwoman Haverilla, Councilman Carnazza and Councilman Gallagher to provide input and oversee these requests.

Borough Attorney Allen Bell reviewed the County Executive's inquiry pertaining to an agreement they sent around stating that the towns take over some of their duties regarding right-of-ways. He reviewed the obligations placed on the Borough that he said did not exist in the past. He recommended speaking with the Northern Valley Mayor's Association and/or the Bergen County League of Municipalities in an attempt to get all the municipalities to join together to argue against the County's request.
