NEW BUSINESS

Filming Permit Fee Waiver Request

Krista Ognibene of 36 Pine Hill Road explained that filming will happen at the end of April or beginning of May. It will take place over a five day period, Monday-Friday from 8AM-6PM. There will be no vehicles left overnight. Monday, Wednesday and Friday there will be two 15ft trucks and four mini-vans and the Ognibene's vehicles. Their neighbor at 16 Greenwoods Road have agreed to let them use their driveway as well. On Tuesday and Friday there will only be four mini-vans.

Police Commissioner Haverilla will speak to Chief Shine about setting up no parking signs temporarily in the area. Traffic will not be affected by this. There may be a fee for this. Mrs. Ognibene agreed to pay this fee.
