COUNCIL COMMITTEE REPORTS

COUNCILMAN BINAGHI – DPW / CONSTRUCTION

All new DPW employees have completed electrical courses at Rutgers. Closed circuit cameras have been installed in the Council Chambers. Eighty-two loads of leaf compost were delivered to residents. Ten new trees have been planted in the playground at Stone Point Park.

COUNCILMAN CIOCE - ENVIRONMENTAL / LIBRARY / HISTORICAL

Councilman Cioce received an email from a resident who complained about the condition of the grounds in the playground area in Stone Point Park. She would like to see rubber mat flooring placed. It was noted that rubber tends to get hot and is very costly. Councilman Cioce will respond to the resident. The Environmental Commission has drafted basic rules for the Community Garden. An Earth Fair wrap up meeting was held; a town to host the Earth Fair for next year will be determined. Upcoming events include paper shredding day, family night and hooked on fishing.

COUNCILMAN NALBANDIAN – FINANCE / FIRE / SCHOOLS / HEALTH / ADMINISTRATION

Board of Health – the Northwest Bergen Regional Health Commission's health educator will hold a presentation at the Old Tappan Senior Center on June 14th pertaining to medication safety. Flyers were distributed for Zumba in the Park to be held on Thursday, May 24th in Westwood. The Board of Health provided a copy of an ordinance from another town prohibiting sale or use of marijuana in all zones. The Board of Health would like to see a similar ordinance adopted by the Mayor and Council. Discussion ensued. It was decided to wait and see what direction the State ultimately decides to take.

COUNCILMAN GALLAGHER – PLANNING / ARTS & ENTERTAINMENT

The Planning Board did not meet in May. Summer concert series are booked for July.

COUNCILMAN CARNAZZA – RECREATION / GOLF / FIRST AID

Our golf team beat Bergen Catholic and are going on to the States. Forty-four kids signed up for Pitch, Putt and Drive. We are hoping that kids age 8 - 12 years old and parents will join our programs at the golf course.

COUNCILWOMAN HAVERILLA – POLICE / SAFETY / SENIORS

Municipal Alliance will present "Hidden in Plain Sight" on Wednesday, 7:30 p.m. at the Fire House. Police Dispatch – we are waiting for Old Tappan to be added to the contract with River Vale.
