NEW BUSINESS

NJ State Chiefs of Police Accreditation Program

Vincent Quatrone, Senior Risk Control Consultant of J.A. Montgomery and retired Lodi Police Chief, was present to clarify the Police Accreditation Program and answer any questions. He provided a handout pertaining to the program and advised that the Borough receives a \$25,000 grant from the Joint Insurance Fund (JIF). A resolution needs to be in place. There is a three-year time frame to use the funds. The 112 standards that are in place help prevent litigation. Included in the standards are promotions, merit and fitness. Codifying rules and regulations of the Police Department is important. It helps lower exposure liability and puts the department in a better position to deal with things that come up. There is a training process and then a maintenance program. The procedure can take up to two years but it brings every policy and rule up to the 2018 standards. This program is recommended by the N.J. State Chiefs of Police. Mr. Quatrone answered questions posed by the Mayor and Council.

Best Practices Checklist

Councilman Nalbandian reported that this is a 61 question survey directed by the state. It has to do with obtaining full grant funding depending on how questions are answered. The Borough had enough "yes" answers to qualify for full state aid. Councilman Nalbandian commented on some of the "no" answered questions.
