ENGINEER'S REPORT

Borough Engineer Thomas Skrable reported as follows:

Conversations with the NJDOT pertaining to reimbursement of funds for the sidewalk project has been resolved. The reimbursement should be resolved shortly.

County Open Space Projects – Oakes Park Gazebo needs to be completed by August. Stone Point Park drainage was discussed.

COUNCIL COMMITTEE REPORTS AND REVIEW OF CORRESPONDENCE

COUNCILMAN BINAGHI - DPW / CONSTRUCTION

Councilman Carnazza and Councilman Binaghi met with the DPW Superintendent to clarify a budget line item of \$5,000 to undercoat five trucks. The budget for playground equipment was modified based on reasonable expected usage. Brine used prior to snow storms has been working well.

COUNCILMAN CIOCE - ENVIRONMENTAL / LIBRARY / HISTORICAL

With the upcoming 125th Old Tappan Anniversary and the opening of the Time Capsule, Councilman Cioce suggested forming a committee. Discussion ensued. Councilman Carnazza will bring this up to the Town Day Committee in a possible effort to combine both Town Day with the 125th Anniversary.

COUNCILMAN GALLAGHER – PLANNING / ARTS & ENTERTAINMENT / FIRST AID

The Planning Board meets next Wednesday; there are 2 applications on the agenda. First Aid has new administration; their focus is on training. There are a lot of new young members taking classes. First Aid Corps did a clean-up of their backyard.

COUNCILMAN CARNAZZA - RECREATION / GOLF / HEALTH

Recreation Commission – the matter of having a boy play on the girls' softball team legally may be allowed. The Baseball and Softball League do not want to finalize the decision. Board of Health meets this month; February's meeting was cancelled due to inclement weather. The Golf Course is closed.

COUNCILMAN NALBANDIAN-FINANCE/ FIRE /SCHOOLS / ADMINISTRATION

SUEZ water is changing the nuts and caps on hydrants and providing new tools to the Fire Department. Board of Education – a board member for the grammar school issued a complaint on the street that connects TBD with CDW for safety reasons. Discussion ensued.
