# COUNCILMAN BINAGHI – DPW / CONSTRUCTION

A letter was received from a resident commending the DPW for the removal of junk in front of their home. The resident commented on the great service they have received in the 40 years they have lived in Old Tappan. A letter was received from Mr. Trout who works in Englewood that they are looking into planning a regional seminar about deer management. Councilman Yhu offered to attend when it is scheduled.

#### COUNCILMAN CIOCE – ENVIRONMENTAL / LIBRARY / HISTORICAL

Due to lack of a quorum, the Library meeting was rescheduled and held on May 15<sup>th</sup>. The Environmental Commission meets tomorrow evening. The 125<sup>th</sup> Anniversary Committee has been having a lot of discussion for the scheduling activities. A 5K Run is also a planned activity for the event. The New Jersey League of Municipalities provided a cannabis information sheet.

# COUNCILMAN YHU - SAFETY / SENIORS / AFFORDABLE HOUSING

Councilman Yhu spoke with the DPW Superintendent who informed him that the quarterly Safety Committee report has been forwarded to the JIF. The committee is reviewing their commercial driver's license policy; their next meeting is June 19<sup>th</sup>. The Senior Advisory Committee meets on June 20<sup>th</sup>. Councilman Yhu is looking forward to working with the Borough Administrator on Community Development.

# COUNCILMAN CARNAZZA - RECREATION / GOLF / HEALTH

Softball – Old Tappan 1 and Old Tappan 3 will play Old Tappan 2 in a rescheduled game at the beginning of June. The Golf Commission received a complaint from a resident pertaining to golf balls in her yard due to removal of trees on a Rockland Electric easement. The Board of Health discussed the measles outbreak and the SUEZ water lead pipes replacement. Councilman Carnazza advised the members to contact SUEZ if they require additional information.

#### COUNCILMAN NALBANDIAN – FINANCE / FIRE / SCHOOLS / ADMINISTRATION

Donna Geitz has resigned as the Police Department Secretary. Applications are being accepted for her replacement. The Fire Department has been discussing painting the truck room and striping of the parking lot; budgeting of funds has to be considered. Two grants they are looking into do not require matching funds from the Borough. Councilman Nalbandian reviewed each one.
