ENGINEER'S REPORT

Street Opening – 1067 North Washington Avenue

North Washington Avenue Street Opening – Mr. Skrable is looking for guidance – PSE&G wants to replace the gas line but will abide by the decision of the town as the road was paved less than a year ago. Mr. Skrable said we can do a curb to curb opening which would be good for aesthetics. The Mayor and Council agreed to Mr. Skrable's suggestion on the curb to curb opening.

He also reported that the 2019 road project went well and was under budget.

COUNCIL COMMITTEE REPORTS

COUNCILMAN BINAGHI – DPW / CONSTRUCTION

The DPW is busy with summer work, cutting grass, checking irrigation systems and maintaining fields. We have a new Construction Official, Bob Rusch, who is working out well; we also have a new fire inspector. Mayor Kramer read a letter from a resident thanking the Fire Department, Ambulance Corps and the DPW for all that they do.

COUNCILMAN YHU – SAFETY / SENIORS / AFFORDABLE HOUSING

Met with the Safety Committee on June 19th. On June 20th met with the Senior Advisory Committee; he told them that we are here to assist them with fire detectors and transportation if they need our help. They do not meet in July and August. The Boy and Girl Scouts would like to get involved with our 125th Anniversary Event.

COUNCILMAN GALLAGHER - PLANNING / ARTS & ENTERTAINMENT / FIRST AID

The Summer Concert Series has begun. Councilman Gallagher thanked the DPW Superintendent and Borough Administrator for their assistance. A Planning Board meeting was held last Wednesday; no new applications were on the agenda. A First Aid meeting will be held on Wednesday; Councilman Gallagher will attend. For the months of May and June, the Ambulance Corps answered 100% of their calls. They are working with the Fire Department and Police Department on a Rescue Task Force Training Drill. Two EMT's and three current EMT's will graduate for a total of five. Councilman Nalbandian suggested placing significant Planning Board applications on the town bulletin board to communicate to residents of the going's on. Discussion ensued.

COUNCILMAN CARNAZZA - RECREATION / GOLF / HEALTH

The Board of Health does not have meetings in July and August. The Golf Commission met and recommended renewal of the Golf Concession agreement. We have 139 registered for golf.

Tonight we promoted Brett Terjanian to Police Lieutenant. Police negotiations are on-going.
