#### **COUNCIL COMMITTEE REPORTS**

#### COUNCILMAN BINAGHI – DPW / CONSTRUCTION

Zoning and Building – visibility at corner lots – some changes were made; on-going process; safety issue. For now, one-on-one basis. Our Zoning Officer wants to create an ordinance on vacant and abandon properties. We will be meeting to discuss his budget. DPW – last leaf pick-up will be early December. Discussion ensued on sharing the DPW Mechanic with other towns for a fee.

#### COUNCILMAN CIOCE - ENVIRONMENTAL / LIBRARY / HISTORICAL

Library – held a meeting last Wednesday; they are getting prepared for their budget meeting. Environmental Commission meets tomorrow evening. They will discuss a Community Tree Recovery / Arbor Day Foundation program. Councilman Cioce's recommendation was to get input from the DPW Superintendent. A 125<sup>th</sup> Anniversary event recap meeting was held, they discussed what worked and what did not work.

# COUNCILMAN YHU – SAFETY / SENIORS / AFFORDABLE HOUSING

We have a girl scout working on her gold award project. Some Senior Advisory Board appointments will expire the end of the year. The Social Service Director will retire effective January 31, 2020. We need some volunteers on the Local Assistance Board. Councilman Yhu will attend the League of Municipalities this week.

COUNCILMAN GALLAGHER – PLANNING / ARTS & ENTERTAINMENT / FIRST AID

The First Aid and Fire Department were reminded that budget meetings are approaching. The Fire Department held their elections they will have the same line officers for 2020. The First Aid Corps will hold their meeting and elections this Wednesday. The Planning Board met last Wednesday; the engineer for the Pearson application did a good job reviewing the proposed plans. The application will be continued next month.

### COUNCILMAN CARNAZZA - RECREATION / GOLF / HEALTH

Recreation Commission – member John Brophy will step down and Kristen Zales has been appointed this evening to take his place. Golf Commission – work on the 9<sup>th</sup> tee will begin. There is a problem with the air conditioning in the club house. Board of Health meets Wednesday.
