Ms. LaFronz stated that on the Chabad website it says religious instruction is offered at 183 Old Tappan Road on a weekly basis. Borough Attorney Allen Bell responded that you have to review what uses are permitted in the zone which the Zoning Officer is looking into. Religious uses are protected by Federal law. Concerns are being addressed with our Planner.

COUNCIL COMMITTEE REPORTS

COUNCILMAN CARNAZZA - RECREATION / HEALTH

At the Recreation Commission meeting, which Councilman Carnazza attended, he reported that Town Day, Tent Dance, Fireworks and registration for sports was discussed. He commented on a parent who has caused a problem for the second time at a game. The Board of Health meets tomorrow.

COUNCILMAN YHU - SCHOOLS / SENIORS

Councilman Yhu advised that he spoke with Dr. Sabatini from NVOT about the incident at a sporting event that Councilman Carnazza mentioned. Community Development – he will be attending a Municipal Innovation Summit at Bergen Community College on March 14th. He will be meeting with our Local Assistance Director to discuss future projects. Technology – met with the committee to discuss plans for a new website they hope to have it completed by mid-year.

COUNCILMAN BOYCE - GOLF / PLANNING BOARD / ENVIRONMENTAL

Planning Board – heard testimony from professionals pertaining to 200 Old Tappan Road. We are looking for members to join our golf course; a commercial that will be airing on channel 12. The Boy and Girl Scouts – Boy Scouts are working on their Eagle projects. The Environmental Commission meets next month.

COUNCILMAN NALBANDIAN - DPW / CONSTRUCTION

Councilman Nalbandian met with the Borough's Construction Code Official to discuss the dangerous intersection list where he mentioned other nuisance violations in town. He asked that we consider hiring a part time enforcement officer to oversee these types of violations throughout the town. DPW – we passed an interlocal shared services agreement tonight with Woodcliff Lake for our mechanic; this will be good for both towns. Our Recycling Coordinator has found ways for the

Borough to make money from recycled equipment.

COUNCILMAN GALLAGHER - FINANCE / FIRE / FIRST AID

The Finance Department is preparing our 2020 budget. Councilman Gallagher reported on incidences and calls with the First Aid Corps and Fire Department.
