PUBLIC'S OPPORTUNITY TO SPEAK

Cara Boyce and Violet Oster, Old Tappan Girl Scout Cadets, are hoping to install a floating library in Oakes Park. This will allow visitors to borrow and share books. You can get books or drop them off at any time. Helps keep people socially distant and hand sanitizer will also be provided. They explained how and what the box and post will be built out of and what it will look like. It will be able to hold approximately 20 books. They provided a handout.

Councilman Binaghi asked if they have seen this done in other places.

Miss Boyce answered yes, she has seen it in other states while on vacation and also locally.

Councilman Nalbandian asked if they had a spot in Oakes Park picked out.

Miss Oster answered that they are going to install it near the parking lot, right by the path so it won't interrupt any sprinkler systems or grass. They have spoken to the DPW Superintendent who gave his approval and will help them install it. They have also spoken to the Library, who liked the idea.

Miss Boyce explained that they first need approval from the Girl Scouts Organization for their fundraising idea and then they will probably start in April or May, once it gets a little warmer out.

Councilman Gallagher stated that he is not sure but he does know that the gentleman is already a firefighter in another town and is our new Fire Inspector. He will find out and report back.

Councilman Yhu asked, for the benefit of the public, for an explanation of what we are hoping to achieve with the resolution in regard to amending the Senate Bill for law enforcement officers.

Councilman Binaghi explained the current cannabis law that was just enacted and how it limits the police's ability to perform their job and makes them libel for a civil suit. They are tying the hands of the police. Our legislators are working to get this changed.

COUNCIL COMMITTEE REPORTS

COUNCILMAN GALLAGHER - FINANCE/FIRE

The Borough family was very saddened to learn of the passing of Lori Langone after a long battle with COVID-19. No arrangements are set at this point but they are accepting donations to help support the family. The Borough Administrator will begin searching for a new Administrative Assistant and is recommending tweaking the position to add some Board of Health responsibilities.

Our CFO, Rebecca Overgaard, has announced that she will be retiring mid-2022. She will be very difficult to replace and will be greatly missed.

Lisa Krivoruk has resigned from the Finance Department so we are in search of a new Accounts Payable Clerk.

The Fire Department continues to respond to all emergency calls day and night. There has been an uptick in commercial and residential fires. Sadly, a young junior firefighter from Ridgefield Park was critically injured while on a call. This shows the dangers that first responders face every day. He highlighted some advances in their technology and how it helps them prior to arriving to a call.

Councilman Boyce had some questions in regard to the new technology.

Chief Kutzin responded to the questions and explained the technology in more detail.

COUNCILMAN BINAGHI – POLICE/AFFORDABLE HOUSING

Read the Police Department activity report for February. Saturday morning there was an apparent double suicide in town, however, the Prosecutor's Office is still investigating.

Councilman Gallagher inquired about what happens internally when a major incident occurs in town. Is there a way for the Mayor and Council to know about it so they don't hear it first from a resident or in the newspaper? How can we do a better job amongst ourselves.

Councilman Binaghi stated that our current Police Chief calls him, as the Police Commissioner, right away and then they discuss who will contact the Mayor. Maybe we should come up with a notification process while remaining cautious and respectful to the people involved. He does not want to compromise any investigation. The best thing to do is contact the Police Chief directly.

COUNCILMAN NALBANDIAN - DPW/CONSTRUCTION

The DPW has repaired all of the damaged mailboxes from this past winter's snowstorms. The Superintendent is currently interviewing for a new hire that we are looking to do later in the year. When he gets a list of candidates he will reach out to the DPW Committee for interviews. They are on schedule for mid-April for their mulch deliveries so orders will begin on April 15th.

Our Construction Code Official is getting ready for a busy year. They discussed how important getting these inspections done the right way is.

COUNCILMAN YHU - FIRST AID/SCHOOLS/SENIORS

Hybrid and virtual learning continue at all Borough schools until further notice. He read in a newspaper article that both the NVRHS and local schools districts will be receiving stimulus money in this latest round.

The Library has reopened for browse and borrow 6 days a week. They receive the insurance claim from the patron that injured his toe on the bike rack.

Now that that weather is improving he is looking to hold an outdoor Senior Citizens Advisory Board meeting hopefully in April.

The First Aid Corps had requested a first responder vehicle during budget time. He took a look at the Police Department's old Expedition vehicle and it seems to be suitable for their use but they will need to customize it to hold oxygen bottles and other equipment. They will probably seek some money to take care of that.

He is looking forward to the community wide event that he will be hosting with Nancy Labov of Alumni in Recovery. He will be introducing the event to our local Board of Health at their next meeting. It will be open to middle age schoolkids and older, along with their parents. This will conclude with their Black Poster Project at Oakes Park on June 5th.

COUNCILMAN BOYCE - GOLF/PLANNING BOARD/ENVIRONMENTAL

The Golf Course is due to open towards the end of this week. They are hoping to have 300 registered members this year. There are a couple of outings already booked. The Concessionaire has paid year to date but moving forward they are going to have to start paying the money they owe us from last year. This past year improvements were made to the Club House. The Superintendent has found a reasonably priced gator that is important for him to have.

In regard to the Environmental Commission, he went over the need for a curb cut and parking lot improvements at the Chestnut Field Community Garden with the DPW Superintendent. They have estimated that to be about \$10,500.00. It will be a modest, simple parking lot. He will discuss this at the next Environmental Commission meeting.

The Planning Board is hoping to have a meeting in April. There are 2 small applications.

The Boy & Girl Scouts are having a car wash this year. They are looking to return to summer

camp. Katie & Ryan Weaver will be taking over the leadership rolls for the Boy Scouts.

He is hoping that there will be a Memorial Day parade this year to honor our Veterans.

Mrs. Haverilla stated that decision needs to be made on whether or not to have the Memorial Day parade.

All were in favor of having the parade but if the weather is bad it will be canceled.

Mrs. Haverilla explained that there are 3 concerts planned for this summer.

COUNCILMAN CARNAZZA - RECREATION/HEALTH

The Recreation Commission is discussing what they are going to do with the seasons. There are no indoor sports planned in any of the schools through at least June. If basketball and baseball seasons are held there will be a limited amount of games. He discussed Town Day and what can be done for that, the date will be September 12th.

MAYOR'S COMMENTS

Reminded the Council to sign on to the JIF insurance seminar. It discusses some very interesting information. We also get a \$250 credit on our insurance rates for attending.

OLD BUSINESS

Oakes House Proposal

Councilman Binaghi received a price on a 30 x 40 building. He passed around a handout. He went to Oakes Park with the DPW Superintendent and measured the area, it came out to be 35 x 40, so it's close. It will cost approximately \$18,000.00 to take the building down and \$65,000.00 to put up the new one with concrete floor, 6 windows, a garage door, 2 people doors, etc. Bathrooms would have to be ADA compliant, hopefully there are some grants available for those. Utilities were discussed. Money will also be needed for finishing the inside of the building and site preparation. He is waiting for other quotes. This will all be discussed at budget time. The basement is not in good shape, the DPW Superintendent is not in favor of saving it. The building will primarily be used for storage, bathrooms and utilities for the park. Other potential uses can be discussed.

Mrs. Haverilla spoke about putting space for the Recreation Director's office there.

Councilman Binaghi then passed around paperwork in regard to Borough Memorials and establishing parameters. He received 2 more requests for memorials so he wants to make sure that we have a consistent set of protocols. He listed the suggested parameters.

Discussion ensued on various potential parameters.

Councilman Boyce suggested a virtual memorial.

NEW BUSINESS

328 Old Tappan Road - Sidewalk Contribution

Councilman Nalbandian explained that the owner would like to make a contribution in lieu of the sidewalk installation. This needs to be approved by the Mayor and Council so the owner can get their certificate of occupancy. Currently there are no sidewalks on that side of Old Tappan Road.
