#### PUBLIC'S OPPORTUNITY TO SPEAK

Discussion – Cherie Fonorow, 256 Old Tappan Road, is seeking information in regard to the status of the potential 244 Old Tappan Road development.

Mayor Kramer explained that an application has been filed with the Planning Board but it has not yet been heard. No plans have been received yet.

Ms. Fonorow is very concerned with the development for a number of reasons - environmental, historical and traffic. It is the wrong place to have a development. Spoke about the public notice that was sent out in regard to the variances that are being sought.

Councilman Boyce explained that the Planning Board is still in a holding pattern until a real, updated application is submitted and a hearing can be scheduled.

Mr. Giblin explained to Ms. Fonorow that the Planning Board is really the proper forum to address her concerns because the Mayor and Council cannot do anything right now. They are removed from the process until it is all the way through the Planning Board.

Councilman Boyce stated that he knows Ms. Fonorow feels very strongly about the environment and the impact this development will have on the town. Once the application comes before the Planning Board then she will have an opportunity to speak on it.

Ms. Fonorow greatly appreciates anything the Mayor & Council can share in order to help her navigate these waters. It is her understanding, from personal conversations, that if the town wants to purchase this property and the owner is willing to discuss it with the town and consider this instead of selling it to a commercial property or something that will not benefit or improve the quality of the town that there is grant money available if applied for. They can only be applied for by the town. Has there been discussions about the town purchasing this property? If the town is not interested then they are going to have to find other benefactors.

Mayor Kramer answered that there have been no discussions by the Governing Body to purchase this property.

Councilman Boyce explained that the Chairman of the Environmental Commission will also be at the Planning Board meeting so he will be able to hear Ms. Fonorow's concerns as well and then relay them to the Environmental Commission.

The Borough's website and email blast system were discussed.

# **Contract Award - Golf Course Management**

Councilman Boyce explained that the Borough received 5 responses to the RFPs. They were then broken down to 2 finalists - Kemper Sports and Indigo Golf Partners. Both of these companies made in-depth, lengthy presentations to the committee. It was a unanimous decision to go with Kemper Sports. They have proven very effective and have offered us the best options for the town. They want to keep the family, town-oriented sense that is currently at the golf course. The review committee included representatives from the DPW, Golf Commission, Men's Club,

Council Members, Borough Administrator, CFO, Borough Attorney and a town resident.

Mayor Kramer spoke to Ray Donnelly, a member of the Golf Commission and Men's Club, who said he felt very good about their decision to go with Kemper Sports. Everyone came away with a good feeling.

Councilman Nalbandian had questions about the contract and how the Borough will fund the golf course now. Did Kemper submit a business plan showing revenues and expenses?

Mrs. Haverilla explained that a contract has not been drawn up yet. Once this resolution is adopted tonight the Borough Attorney will begin working on the contract in conjunction with Kemper Sports. She explained the management fee and what it includes. Kemper will be taking over the concession and pro shop. They will hire all of their employees but with our approval. Financially, all of the money comes to the Borough and then we fund them for their expenditures. They have buying power.

Ms. Overgaard explained how we will fund Kemper at the beginning of the year when everything starts up. An interfund will need to be established.

Councilman Carnazza explained that Kemper Sports looked at the last 3 years of our financials, expenses, salaries, benefits, and told us that for the first 3 years the Borough will make between \$50,000 - \$100,000 over and above the number that we have now in gross revenue.

#### COUNCILMAN BINAGHI – POLICE/AFFORDABLE HOUSING

Read the Police Report for October. The 2 new officers that we hired have completed all of their requirements and will be sworn in on December 6<sup>th</sup>. The Chief sent an email in regard to the

accreditation program and where we are at in the process. He will forward the email to everyone.

### COUNCILMAN NALBANDIAN - DPW/CONSTRUCTION

The DPW had a new employee appointed tonight who will be replacing our recent retiree. They continue to pick up leaves and are continuing with their parking lot renovations.

The Construction Office continues to be busy. There has been a lot of activity over at the former Pearson property. The property on Central Avenue has been cleared for another new development.

#### COUNCILMAN YHU – FIRST AID/SCHOOLS/SENIORS

Our Seniors remain very active.

The Library Board will be meeting tomorrow with 2 new members. A new resident welcome package is being worked on.

Our residents re-elected the incumbents to the local Board of Education. 2 new members were elected to the regional high school Board of Education. He is looking forward to working with all of them. NVOT will be hosting their new production November 18<sup>th</sup> - November 20<sup>th</sup>. The NVOT girls' volleyball and cross-country teams won their sectional championships. The NVOT boy's junior varsity soccer team won the Bergen County Championships. The NVOT marching band are the new Group 2A state champions.

The First Aid Corps is making progress on obtaining funding from the local and regional PTOs to purchase ballistics gear. The OTFAC President is asking for the Mayor and Council's support in regard to the League of Municipalities resolution urging the NJ Legislature to create legislation that would establish emergency medical services as essential government services. He will have discussions about this while at the League of Municipalities Conference this week.

### COUNCILMAN BOYCE - GOLF/PLANNING BOARD/ENVIRONMENTAL

There is a strong environmental contingent in town who are concerned with 244 Old Tappan Road. He described the environmental characteristics of this property and what needs to be done to develop on it. He asked if the Council has any interest in buying the property before any new information comes in from the developer to go before the Planning Board. They do not know the price because there has never been an opportunity to negotiate with the developer. There are grant opportunities. He described the different paths this property could go down.

Mr. Giblin asked if anyone has spoken to the owner of the property? Do they have the right to sell it? There is probably already a contract between the owner and the developer. The developer would not leave the property open to getting sold out from under them.

#### COUNCILMAN CARNAZZA – RECREATION/HEALTH

He received reports from the Board of Health and we have 2 more COVID-19 cases. He will learn more at his meeting Wednesday.

Last Saturday was the Halloween Festival at Oakes Park.
