## COUNCILMAN YHU – DPW/CONSTRUCTION/FIRST AID

The Seniors had a great time at their 50's themed dance party. The committee has been doing a great job this year to get our seniors active post-COVID.

The First Aid Corps elected their 2023 officers. They were at the scene of a recent house fire in town.

Thanked our 2 DPW members who are also firemen for also being at the recent house fire - Dan Hartman and Tom Jung.

Councilman Gallagher inquired about the status of the house at the corner of Kristin Place and Old Tappan Road that we gave permission to allowing them to keep the old home up until the new home was completed.

Councilman Yhu spoke about this with the Construction Official awhile ago and he explained that there is nothing out of the ordinary given the situation that COVID put everyone in finding materials and contractors to do the work. As long as the permit is open the homeowner is allowed to continue and keep that other house up.

Councilman Carnazza asked Mr. Giblin if the tent at a house on Kristin Place can be up all the time?

Mr. Giblin said no, it is a temporary structure and cannot remain there permanently.

#### COUNCILMAN CARNAZZA – RECREATION/HEALTH

A request was made by the Golf Course to fix a leaf blower machine which the DPW helped with. They are preparing the 2023 budget.

December is likely the last Planning Board meeting for the 244 Old Tappan Road application. The public will have an opportunity to speak.

The Environmental Commission should be receiving the tree report on 244 Old Tappan Road and will report back to the Planning Board before the December meeting.

The Boy Scouts need a decision on where to park their new trailer.

Councilman Yhu stated that they have found a place for the trailer at the leaf dump and he has asked Ryan Weaver to contact the DPW Superintendent to make arrangements.

Councilman Carnazza reported that the Board of Health meeting from last week was rescheduled to tomorrow night.

Councilman Yhu reported that he spoke to a woman at the League Conference who commented on how great of a job Dr. Bhatia and her daughter did on the Mayor's Wellness Campaign.

## **Certificate of Occupancy Ordinance Amendment**

Councilman Yhu forwarded to the Mayor & Council earlier in the month the proposed changes and asked if anyone had comments. Currently we do not have listed in the ordinance items that need to be completed before a Certificate of Occupancy is granted to the seller or renter of their home. Listed the Construction Official's suggestions. There is a fee and penalty schedule that goes along with this as well.

Mayor Kramer is concerned with those who are looking to sell an older home that has certain deficiencies that were acceptable years ago will now face a hardship. Wants to be careful with how far we go with this.

Discussion ensued on the Construction Official's suggestions.

Councilman Nalbandian agrees with the Mayor.

Councilman Binaghi is in favor of the sump pump regulations.

Councilman Gallagher is in favor of the electrical regulations and would like to know what other towns are doing. Asked if we have any liability by not doing certain things.

Mr. Giblin explained that the only thing the town is required to do under state law is the smoke detector certification. No other inspections are required. Open permits need to be closed.

Mayor Kramer stated that it seems like the only item the Council is interested in is the sump pump into the sewer system.

Councilman Yhu will speak with the Construction Official about the Mayor and Council's concerns and we'll work on the ordinance more.
