ENGINEER'S REPORT

Mr. Skrable reported that the 2022 Road Paving Program is ready to begin. They are looking to start milling next Friday, September 16th and continue through the next week subject to the weather. He read the list of streets to be paved. The residents will be notified the beginning of next week. The Perry Street drainage project should begin in October, they are still waiting on the pipe.

Councilman Yhu questioned the elevations of the 2 buildings being constructed at the corner of Old Tappan Road and Washington Avenue because they seem to be different.

Mr. Skrable explained that they meet all the height requirements. The height is all based on the access point and they will be accessed from different streets.

Councilman Binaghi inquired about the drainage issues at The Enclave. He is concerned with how it will affect the properties surrounding it.

COUNCIL COMMITTEE REPORTS AND REVIEW OF CORRESPONDENCE

COUNCILMAN BOYCE – GOLF/PLANNING BOARD/ENVIRONMENTAL

A member at the golf course was injured and can no longer golf so he has requested that the balance of this year's membership fee be applied to 2023. He has been a member in good standing for the last 8 years.

The Mayor and Council were in favor of this.

The Golf Committee will have a meeting this fall to discuss a small increase in membership fees to keep up with the cost of expenses. They will work with the CFO to see how the golf course is fairing financially.

A common practice at the golf course has been to take in membership fees between September and January for the next year and then allowing these people to play for the balance of the year that they paid in. They would like to continue with this provided the Mayor and Council are in favor of this. He feels it is a good idea.

The Mayor and Council were in favor of this.

The Environmental Commission is working with a landscape architect/arborist for the 244 Old Tappan Road Planning Board application. A tree survey is being conducted and a report will be provided to the Environmental Commission who will then make a recommendation to the Planning Board weighing in on the impact of removing those trees. It is a report in progress right now. He explained the status of the 244 Old Tappan Road application and what still needs to happen before the Planning Board votes. It will probably take another 3 to 4 meetings.

He received a letter from the Environmental Commission Chairman in regard to a development in Orangetown, NY that abuts the Waters Edge development in Old Tappan. A data center is being built.

Mrs. Haverilla explained that the Environmental Commission could send the Orangetown Planning Board a letter. There are a lot of people, including Senator Schepisi, working on this project on behalf of the Old Tappan residents right now. In the past they have not been receptive to our input. One of the neighbors contacted her and she told them that she

will send them anything the Borough receives from Orangetown.

Mayor Kramer suggested having the Borough Attorney draft a resolution that can then be sent to Orangetown.

Councilman Boyce stated that at the next Environmental Commission meeting they will review the Orangetown application and speak with the Borough Attorney so a letter can be drafted and sent.

COUNCILMAN GALLAGHER - POLICE/GRANTS

It is encouraging to see our new grant consultants starting to look for opportunities for the Borough.

COUNCILMAN BINAGHI - FINANCE/ADMINISTRATION

The Tax Collector reports that the Tax Sale is scheduled for October 14th. Gave the current number of tax and sewer account delinquencies. Final 2022/preliminary 2023 tax bills are being processed and will be mailed the week of September 12th.

COUNCILMAN YHU – DPW/CONSTRUCTION/FIRST AID

The Seniors will be having a Lunch and Learn on September 29th, an International Luncheon on October 27th, the Christmas Luncheon December 15th and they will be participating in Town Day.

The First Aid Corps has reached out to the grant consultants for opportunities. To help alleviate some of the load on our volunteers he would like to meet with the committee to discuss the plausibility of enacting an ordinance to require nursing homes and other group homes to provide their own modes of transportation for non-emergencies.

The Construction Department remains busy. Some of the inspectors have begun using the Borough vehicle they were allocated. During budget season we can discuss getting them a new car.

The DPW has continued with ash tree removal and stump grindings. They painted all stop lines, crosswalks, curbs and parking spots throughout the town as well as doing work at the Community Garden and performed maintenance on all of the parks and playgrounds. All the playgrounds passed the required safety inspections.

COUNCILMAN NALBANDIAN - FIRE/LIBRARY/SCHOOLS

The Fire Department will have their Inspection Dinner on September 30th. The Chief and Deputy Chief attended a symposium in New York run by the FDNY on lithium ion battery training.

MAYOR'S COMMENTS

Was at a meeting of the Police Chief's Association and it was reported that car thefts continue at a very high rate. One of the biggest problems is that most of these cars are being stolen by juveniles and there is no action being taken against them. The legislature needs to do something about the bail reform measures that were adopted. The Chairman of the association suggested that Mayor and Council's begin adopting resolutions to put pressure on the legislature to amend the bail reform measures.

He received an email from former Mayor Victor Polce informing him that his father has passed away and gave the service details.
