# **OLD BUSINESS**

# **First Aid Corps**

Councilman Yhu explained that there are ongoing discussions on our ambulance services and how we want to provide the services that our residents expect and deserve. We received 2 proposals today from Hackensack Hospital and Holy Name Hospital. He described what each proposal contains. These proposals will be forwarded to the Mayor and Council for review. Invited the First Aid Corps members present to give their views.

OTFAC Chief, Jesse Hopfer, spoke in regard to their budget request for paid EMTs. He understands that the dollar amount proposed is high but feels that the benefits of hiring our own EMTs to serve Old Tappan outweighs the price concerns. Hiring the EMTs allows for a quick response time. Even if we have a contract with a hospital, residents might still have to pay for the services they receive. Contracts with hospitals can also prohibit the OTFAC from operating during the time period that a contracted ambulance is in service. There are only downsides with contracting with a hospital.

Discussion ensued on paid EMTs versus contracting with a hospital including other town's experiences, mutual aid and budgeting for these services.

Mayor Gallagher stated that if we were to even consider the OTFAC's proposal it would be contingent upon River Vale's involvement. The budget numbers need to be worked on further and passed on to the Mayor and Council.

Councilman Yhu will reach out to River Vale again to see where they are at.

Chief Hopfer reported the OTFAC's February response statistics.

Councilman Yhu explained that he has attended several seminars on this topic and no one recommends that towns contract with a hospital because it ruins the volunteer first aid corps. Asked Chief Hopfer to elaborate on this.

Chief Hopfer explained that it is mainly because there are situations in the contract that says the OTFAC cannot respond which prevents new members from getting any experience. It would reduce the morale. The Mayor and Council might be able to negotiate these items with the hospital. They can also run the numbers for hiring per diem EMTs if the Mayor and Council are interested.

Discussion ensued on hiring per diem EMTs.

Mayor Gallagher would like to keep this conversation open and would like to know how our mutual aid towns are doing with their services. We have to be fiscally responsible but we also have to weigh in response time.

#### **ENGINEER'S REPORT**

Mr. Skrable reported that there was a preconstruction meeting last week for the Russell Avenue improvements which is a DOT project. Explained what the project entails. The contractor is looking to start the concrete work soon and then do the milling and paving during spring break week for the schools. The other project is DeWolf Road which started today. They are just doing the drainage work now because that will need to settle prior to doing the mailing and paving. This is also a DOT project. They are beginning to work on the Borough's paving program. There is another grant for phase 2 of the Perry Street drainage that is just getting started.

Councilman Boyce asked about the silt for the DeWolf Road project.

Mr. Skrable explained that the drainage ties into an existing pipe that runs all the way down DeWolf Road and ties into Dorotockey's Run. There will be basins installed on both sides of the street and they are recreating the crown in the road.

Councilman Yhu asked if the First Aid Corps and Fire Department will have any access issues during the Russell Avenue project.

Mr. Skrable stated that this was discussed in detail during the preconstruction meeting. We will make sure that everyone is aware of exactly what is going on. The rigs will be out of the building overnight for one night and placed somewhere they can respond from. The DPW Superintendent was involved in those discussions and has a plan in place.

Councilman Boyce asked about the status of reconfiguring the front end of the Borough Hall entrance and possibly the ramp going into the second story of the firehouse.

Mr. Skrable explained that there was a rough concept done but it would be a very expensive and complicated project.

Mrs. Haverilla asked if we can still move the parking lot entrance over so the ramp no longer goes right into it.

Mr. Skrable answered yes, we can make that situation better. We would just need a road opening permit from the county.

# COUNCIL COMMITTEE REPORTS AND REVIEW OF CORRESPONDENCE

# COUNCILMAN GWON - FINANCE/LIBRARY

The OEM Coordinator has been looking at a few companies for mass notification platforms for emergency alerts and normal day to day communications for residents.

The Library Board will be inviting the potential student board member for an interview at their next meeting. This was a recommendation from the Youth Council. Read the February 2024 activity report.

# COUNCILMAN BOYCE - GOLF/PLANNING BD/ENVIRONMENTAL

The Veterans are continuing their work on the Veterans Memorial at Oakes Park. They would like to acknowledge a WWII veteran prior to Memorial Day so they are looking into the materials to make that happen. They would also like to create a drop box for used flags and then have a ceremonial flag burning once a year. This could be a potential Boy Scouts project.

The Environmental Commission suggested that any funds generated from the tree removal permits could go into a salary/stipend to compensate a professional forester or arborists to help the Construction Official with these permits and inspections. They also suggested that they become a 501-C3 organization so that they can bring in donations.

Mr. Giblin explained that the Borough could do a dedicated trust by rider which people can donate to and is tax deductible.

#### COUNCILWOMAN MASSARO - RECREATION/HEALTH/HISTORICAL

The Board of Health discussed organizing another town wide walk at Stone Point Park this spring. They would like to offer a way to check the smoke detector batteries for seniors when we move the clocks forward. The results of the NJ Healthy Towns will come out this month.

The Historical Committee is waiting for the Heritage Tree sign to be made so that a presentation can be made at Bonnabel Park. They are working on setting up a guest speaker for May. Former Mayor Kramer brought in some Old Tappan artifacts that will be displayed upstairs at the firehouse.

The Youth Council will meet later in the month. The numbers and interest are growing. The NVOT newspaper is writing an article about them.

# COUNCILMAN CARNAZZA - DPW/CONSTRUCTION

Read the DPW activity report.

Read the February 2024 Construction Department activity report.
