**ORDINANCE NUMBER 1273-25  
AN ORDINANCE AMENDING CHAPTER 119 OF THE CODE OF  
THE BOROUGH OF OLD TAPPAN ARTICLE III RECREATION PROGRAM FEES**

**BE IT ORDAINED** by the Mayor and Council of the Borough of Old Tappan as follows:  
**Section 1. Ordinance 119-9" is removed in its entirety and is replaced with the following:**

**ARTICLE III  
Recreation Program Fees**

**§ 119-9. Registration fees.**

The following are the registration fees for the Borough's recreation programs. The fee range shown is for the 2025-2027 calendar years. The Recreation Commission shall set the registration fees for each of the calendar years 2025 through 2027 in an amount not to exceed the amount shown.

**A. Baseball/softball.**

**(1) Registration fees for baseball-recreation:**

Program	Fee
T-ball	\$50 to \$170
Pee Wee	\$60 to \$180
Minor	\$85 to \$205
Majors	\$85 to \$205
Knickerbocker	\$120 to \$245
Late fee	\$25 - \$125

**(2) Registration fees for softball-recreation:**

**(3) Winter clinics, all grades: \$125 to \$350.**

**(4) Travel baseball, all grades: \$300 to \$500 per season.**

**(5) Co-ed softball, all grades: \$60 to \$115.**

**B. Soccer.**

**F.** Additional clinics/programs, all grades: \$25 to \$75.

**G.** Arts and entertainment.

**(1)** Townwide garage sale fee: \$20 per household.

**(2)** Art in the Park: \$20 per space.

**H.** Pickleball:

**(1)** Individual adult: \$45 to \$60.

**(2)** Senior citizen (65 years old +): \$35 to \$60.

**(3)** Youth (12 years old to 17 years old): \$35 to \$60.

**(4)** Under 12 years old: free (must be accompanied by an adult).

**Section 2. Repealer**

All ordinances or parts of ordinances inconsistent or in conflict with this Ordinance are hereby repealed as to said inconsistencies and conflicts.

**Section 3. Severability**

If any section, part of any section, or clause or phrase of this ordinance is for any reason held to be invalid or unconstitutional, such decision shall not affect the remaining provisions of this ordinance. The governing body of the Borough of Old Tappan declares that it would have passed the ordinance and each section and subsection thereof, irrespective of the fact that any one or more of the subsections, sentences, clauses or phrases may be declared unconstitutional or invalid.

**Section 4. Effective Date**

This ordinance shall take effect upon passage and publication according to law.
