

**BOROUGH OF OLD TAPPAN  
ORDINANCE NO.**

**AN ORDINANCE SUPPLEMENTING CHAPTER 119, “FEES” OF THE  
CODE OF THE BOROUGH OF OLD TAPPAN TO AMEND THE FEES  
CHARGED FOR USE OF THE OLD TAPPAN GOLF COURSE**

**WHEREAS**, the Golf Management Company Kemper Sports Management, Inc. has recommended to the Mayor and Council that the fees charged for use of the municipal golf course be amended;

**WHEREAS**, the Mayor and Council has determined that the golf course fees should be amended as set forth herein;

**NOW THEREFORE, BE IT ORDAINED** by the Mayor and Council of the Borough of Old Tappan, County of Bergen, State of New Jersey, as follows:

**Section 1. Section 8 of Chapter 119 of the Code of the Borough of Old Tappan, titled “Fees”, is hereby repealed and replaced by the following:**

**119-8. Fees, Rents and other charges.**

Fees are not refundable. Full payment must be paid by January 1.

A. **Non-Resident Membership:** The following are the guest fees, cart rentals and other charges for admission to and use of the Old Tappan Golf Course:

B. **Old Tappan Resident Membership:** Old Tappan Residents Only (Green fee included) Resident (the term “Resident” shall include residents of Woodcliff Lake who present satisfactory proof of residency, for so long as a shared service agreement exists between Old Tappan and Woodcliff Lake).

**Section 2. Repealer**

All ordinances or parts of ordinances inconsistent or in conflict with this Ordinance are hereby repealed as to said inconsistencies and conflicts.

**Section 3. Severability**

If any section, part of any section, or clause or phrase of this ordinance is for any reason held to be invalid or unconstitutional, such decision shall not affect the remaining provisions of this ordinance. The governing body of the Borough of Old Tappan declares that it would have passed the ordinance and each section thereof, irrespective of the fact that any one or more of the subsections, sentences, clauses or phrases may be declared unconstitutional or invalid.

**Section 4. Effective Date.**

This ordinance shall take immediate effect upon passage and publication according to law.
